# Computer User Policies, Middle School, St. Gerard Majella School 2020-21

The school's information technology resources, including Internet access, are provided for educational purposes. The Internet, computers, and other electronic devices give students access to information, and allow them to collaborate with others. The advantages of using digital tools far outweigh the risks. Nevertheless, St. Gerard Majella School is aware of the hazards of websites with objectionable material, and the potential for online harassment of students.

With the privilege of using these comes the responsibility to use them ethically. In order to protect students, we have established these acceptable use procedures. The student and the school share responsibility for safe, ethical, and productive use of the Internet, electronic media, and devices.

### St. Gerard Majella School will

- Provide access to the Internet, computers, and other electronic devices.
- Provide the opportunity for students to use technology to work together, solve problems creatively, and develop search skills.
- Ensure that filtering is in place to block inappropriate material, including websites that are offensive, obscene or pose a security risk.
- Ensure that no recognizable photos with full names of students appear on websites or social media sites operated by the school.
- Teachers will provide guidelines for use of the Internet and monitor the use of technology.
- Teachers will inform students of their rights and responsibilities toward electronic media.

#### Students must

- 1. Respect and protect the privacy of others.
  - Use only assigned accounts.
  - o Not view, use, or copy passwords, data, or networks to which they are not authorized.
  - Not distribute private information about others or themselves.
  - o Not send anonymous messages of any kind.
  - No personal addresses, personal phone numbers, or last names of students may be published on the Internet.
  - Not share videos, recordings, or images that include students or teachers of St. Gerard Majella School online unless given permission to do so.
  - Not use the camera or video recording capabilities of the laptop, Chromebook, or iPad unless given permission to do so.
- 2. Respect and protect the availability, and security of all electronic resources.
  - Report email phishing, problems with account security or technology violations to a teacher or administrator.
  - Not destroy or damage files, devices, networks, or other resources or purposely make them more difficult to use.
  - Not damage laptops, laptop, Chromebook, or laptop, Chromebook, or iPads, or other devices on purpose or through careless behavior.
  - Not change the operating system, preferences or settings of computers or install software without permission.
  - Not make use of software or extensions that bypass the school's Internet filter or network security.
