 The website is https://www.preventandprotectstl.org. In order to register, you will need your social security number and a valid credit card. The fee is \$8.00 per person. Each applicant is responsible for the \$8.00.

Once you have completed these steps you will be in compliance for all SGM activities involving children. If you think you are already in compliance, you may call the parish office to verify your compliance status.

# \* February 25 and 26 KINDERGARTEN SCREENING TEST

The children will be given the Missouri KIDS screening test at school. (2005 Dougherty Ferry Road) on Thursday, February 25<sup>th</sup> and Friday, February 26<sup>th</sup>. The screening test is administered to validate readiness and aid in Kindergarten curriculum planning.

WHEN YOU RETURN THE COMPLETED REGISTRATION PACKET, YOU WILL SIGN UP FOR A TIME FOR KINDERGARTEN SCREENING IN THE MAIN OFFICE. (Preschool students may sign up during the school day/preschool hours. The preschool staff will walk your child over to testing.)

The screening will be held in Parish Meeting Rooms. Please park on the Church side of the island when you arrive. The students need to wear closed toed/athletic shoes due to some movement that they do for screening. We suggest arriving about 5 minutes early for your scheduled testing time.

Primary teachers will be administering the Missouri KIDS screening test. Parents and students will arrive to Parish Meeting Room 227 and wait for a teacher to take your child to screening. After your child is taken back for screening, due to COVID restrictions, we ask that the parent wait in the car until screening is complete. The screening usually takes about 45-50 minutes. After the screening, a teacher will walk your child out to the car to meet you.

As we continue to take precautions to keep everyone safe from COVID, your child will need to wear a mask during testing and if your child is experiencing any symptoms or has been exposed, please call school for a reschedule date of testing. If you have and additional questions before Thursday, February 25<sup>th</sup>, please call the school office at (314) 822-8844 ext. 2.

You will be notified of acceptance into the class in mid-March. The date of the new Kindergarten Parent Meeting will be included in the acceptance letter.
